WHEREAS by virtue of Order No. _____ the Lieutenant Governor in
Council authorized the issuance of a special grant to the Board subject
to certain terms and conditions;

AND WHEREAS the said Order-in-Council authorized the Minister and the
Board to establish such other terms and conditions respecting the said
grant as they may deem necessary;

WITNESSETH that the parties hereto covenant and agree together as
follows, namely:

1. **The Board and the Minister agree the goals and objectives of the
Community School Program shall be:**

(a) **to have community involvement in the establishment of acti-
vities and programs related to the community school;**

to provide for the development of activities which will
enhance the education of both children and adults;

(b) to assist in creating a safe neighborhood environment for
the physical well being of the children of the community
school;

(d) to foster positive racial and cultural understanding within
the community school and within its community;

(e) to foster activities which will bring about closer relation-
ships between the community and its school;

(f) to actively involve parents and other community residents in
the community school decision-making process, through the
Community School Council regarding community school policy,
curriculum, finance, facilities and staffing procedures;

(g) to foster a sense of community and to improve the quality
of life in the community school's neighborhood;

(h) in co-operation with other agencies, to provide information
relating to educational and community activities;

i to encourage residents of the community to be involved in
the identification and initiation of adult activities in the
community school and in the community itself;
